The mandate is unequivocal: **Eliminate fragmentation at its source or watch your legacy erode through generational transitions.** The time for systematic transformation is now.

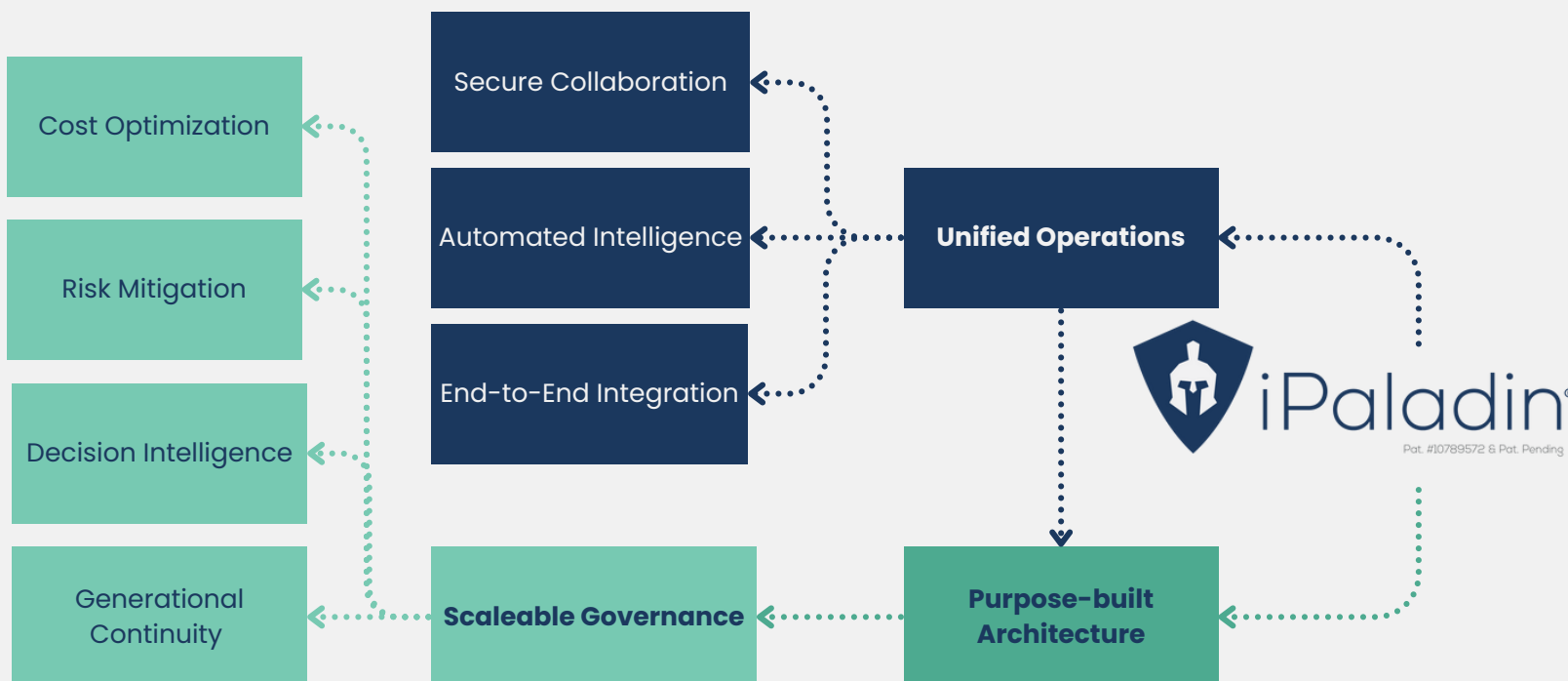
COST OF FRAGMENTATION
